

**CITY OF MUSCATINE
REGULAR CITY COUNCIL MINUTES
7:00 p.m. – July 15, 2021**

Mayor Broderson called the City Council meeting for Thursday July 15, 2021, to order at 7:00 p.m. Present were: Councilmembers Hopkins, Froelich, Gordon, Brockert, Jindrich, Malcolm and Brackett.

The Council meeting began with the pledge of allegiance.

Ed Chamberlain, President of Muscatine County Arts Council and Annette Hogland, came to give a presentation on the Wandering Words Program and to request continuing support of this program. They shared that with this year's poems there will be 30 unique poems located on sidewalks throughout Muscatine.

Police Chief Brett Talkington was present to give an update on the 2021 fireworks calls and citations for the City of Muscatine. Chief Talkington stated the department has taken a zero tolerance policy towards the illegal use of fireworks and increased the total number of citations issued in 2021. He stated they plan to move forward with this strategy with the hopes of keeping the firework incidents at a minimum.

There was discussion from City Council regarding the types of fireworks found at the calls, the amount of the fine when a citation is issued, the number of calls received and other options moving forward with fireworks regulations.

Parks and Recreation Director Rich Klimes was also present to share the issues with 4th of July trash firework debris that had be cleaned from the Riverfront and City Parks.

Diana Moore, 507 Adams Street came to share concerns with the alley in her neighborhood, stating that the crushed concrete the City is applying contains nails, wires and screws. She shared concerns that this alley is number 25 on the list of alleys to be repaired and that it needs to be done prior to other alleys that are being repaired. Mayor Broderson stated she would get more information regarding this for Ms. Moore.

Jean Clark, 1221 Mulberry Avenue, came to encourage the citizens of Muscatine to sign up through MPW's Choose Green Muscatine. Ms. Clark states this is a way of choosing what percentage of your energy for your home is renewable energy. Ms. Clark shared that MPW uses this program to evaluate the need and desire for renewable energy in our community.




