

**CITY OF MUSCATINE
REGULAR CITY COUNCIL MINUTES
7:00 p.m. – March 17, 2022**

Mayor Bark called the City Council meeting for Thursday March 17, 2022, to order at 7:00 p.m. Present were: Councilmembers Hopkins, Gordon, Jindrich, Osborne, Brockert, Froelich and Lewis.

The Council meeting began with the pledge of allegiance.

Mayor Bark presented a proclamation regarding Junior Achievement Day to Joy Dodson, Vice President of Community Relations for Junior Achievement of the Heartland. Ms. Dodson thanked the City for their support of JA.

Roger Roth, Clark House, was present to share his disagreement with the current mask mandates on public transportation.

Ron Henderson, 5820 63rd Avenue West, was present to discuss the junk vehicle codes passed by the City Council. Mr. Henderson shared his concerns with the way the City is handling the issue of a nuisance presented by his neighbor.

Public Hearing

A public hearing was held regarding the proposed Fiscal Year 2022/2023 budget. Finance Director Nancy Lueck gave a presentation on the proposed budget highlights.

A public hearing was held regarding the proposed amendment #1 to the Fiscal Year 2021/2022 budget.

Councilmember Gordon moved to close the public hearing, seconded by Councilmember Lewis. Vote: Ayes – 7, Nays – 0, Motion carried.

From the City Administrator

11A: Councilmember Brockert moved to adopt on third and final reading, Ordinance #2022-0063, revising Title 1, Chapter 2, Section 14 of the Code, relating to standard penalties. Seconded by Councilmember Gordon.

11B. Councilmember Gordon moved to adopt Resolution #2022-0101, approving the City of Muscatine budget for fiscal year ending June 30, 2023. Seconded by Councilmember Brockert. Vote: Ayes – 6, Nays – 1,(Jindrich) Motion carried.

11C: Councilmember Froelich moved to adopt Resolution #2022-0102, approving amendment #1 to the fiscal year 2021/2022 budget. Seconded by Councilmember Lewis.

Vote: Ayes – 7, Nays – 0, Motion carried.

11D: City Administrator Webb stated she had made a change to the item replacing bi monthly with bi weekly meetings. Councilmember Lewis moved to adopt Resolution #2022-0103, establishing a Leadership Planning Committee as a subcommittee of the City Council. Seconded by Councilmember Froelich.

11E: Councilmember Gordon moved to adopt Resolution #2022-0104, setting a public hearing on an ordinance striking Title 6, Chapter 9 of City Code, regarding the keeping of pit bull dogs. Seconded by Councilmember Lewis.

Vote: Ayes – 5, Nays – 2,(Jindrich, Froelich) Motion carried.

11F: Councilmember Brockert moved to adopt Resolution #2022-0105, authorizing the execution of a quit claim deed for parcel #08354840111 to the adjoining property owner, First National Bank, Seconded by Councilmember Lewis. There were questions from City Council asking for clarification of the location of this parcel that were addressed by City Administrator Webb.

Vote: Ayes – 7, Nays – 0, Motion carried.

11G: Councilmember Froelich moved to adopt Resolution #2022-0106, setting a public hearing on an ordinance establishing vacant property and nonresidential property maintenance regulations. Seconded by Councilmember Brockert.

There were questions from City Council regarding the time frames suggested in the proposed ordinance and clarification of vacant and nonresidential property definitions that were addressed by City Administrator Webb and Assistant CD Director, Andrew Fangman.

11H: Councilmember Grodon moved to adopt resolution #2022-0107, setting a public hearing on an ordinance regulation cargo containers in residential areas. Seconded by Councilmember Brockert.

11I: Councilmember Froelich moved to adopt resolution #2022-0108, setting a public hearing on an ordinance revising weed and vegetation management regulations. Seconded by

Councilmember Gordon.

11J. Councilmember Hopkins moved to adopt resolution #2022-0109, setting a public hearing on the 2023 consolidated funding application for Muscabus. Seconded by Councilmember Lewis.

11K. Councilmember Froelich moved to adopt resolution #2022-0110, setting a public hearing on the community needs assessment and proposed use of community development block grant funds.

Seconded by Councilmember Brockert.

11L. Councilmember Hopkins moved to adopt resolution #2022 – 0111, setting a public hearing on the plans, specifications and form of contract for the Transfer Station tipping floor project, Seconded by Councilmember Jindrich,

11M. Councilmember Gordon moved to adopt resolution #2022-0112, awarding the Taylor Park Improvement Project Contract to All American Concrete, in the amount of \$429,584.00. Seconded by Councilmember Brockert.

11N. Councilmember Hopkins moved to adopt resolution #2022-0113, awarding the Taylor Park Splash Pad Project to The Henley Group, LLC in the amount of \$333,000.00. Seconded by Councilmember Froelich.

11O. Councilmember Jindrich moved to adopt resolution #2022-0114, setting a public hearing on an ordinance amending City Code regarding residency requirements. Seconded by Councilmember Gordon.

11P. Councilmember Jindrich moved to approve request #2022-0115, for a date extension of the current Federal Transit Administration Contract for replacement of bus 246. Seconded by Councilmember Froelich.

11Q. Councilmember Gordon moved to approve request #2022-0116, for a development agreement from Ken LaRue for a .93 acre parcel located at the corner of Park Avenue West and Peachtree Street. Seconded by Councilmember Osborne.

11R. Councilmember Brockert moved to approve request #2022-0117, for change order #9 for the Grandview Avenue Reconstruction Project, Seconded by Councilmember Gordon.

11T. Councilmember Froelich moved to approve request #2022-0119, for a development agreement with Muscatine Center for Social Action for demolition of property at 519 E. 7th Street. Seconded by Councilmember Jindrich.

11U. Councilmember Hopkins moved to approve request #2022-0120, for the issuance of a purchase order to Bonnell Industries in the amount of \$7,172,15 for the purchase of a stainless-steel dump body. Seconded by Councilmember Gordon.

11V. Councilmember Lewis moved to approve request #2022-0121, for the issuance of a purchase order to the Fire Store, in the amount of 13,298.00 for the purchase of a Circul-air Jet hose washer. Seconded by Councilmember Gordon.

11W. Councilmember Froelich moved to adopt resolution #2022-0125, setting a public hearing on the plans and specifications to widen a portion of the Muscatine Airport Taxi lane. Seconded by Councilmember Brockert.

Councilmember Lewis reminded citizens that as the weather gets warmer to look out for motorcycles and for children when driving.

Councilmember Lewis congratulated the new firemen that completed their training.

Councilmember Brockert stated her concern regarding feeling threatened by a citizen.

Councilmember Froelich motioned the meeting be adjourned at 8:12 pm.
