**INTRODUCTION:** Attached hereto please find the resolution endorsing FY13 municipal airport projects and certifying the availability of matching funds.

**BACKGROUND:** State of Iowa airport funding through the IDOT requires cities to take action to officially endorse airport improvement projects and state that they have local matching funds available to meet the 15% local share. It **does not** commit the City (financially) to move forward at this time. As with other airport projects, the City Council must specifically approve each project grant agreement during the respective fiscal year it is programmed and following a state and/or federal determination that funding is available.
