INTRODUCTION: Stanley Consultants has completed the plans and specs for renovation of the Bond and Schley lift stations. Estimated cost is around \$200,000. A public hearing is required. Because of the change in the contract with Stanley Consultants, the original resolution setting the public hearing needs to be changed from June 7, 2012 to June 21, 2012.

RECOMMENDATION/RATIONALE: Attached is a resolution setting a public hearing for June 21, 2012. This resolution needs to be on the agenda for the June 7, 2012 council meeting. There is currently \$300,000 budgeted for the renovation of these two lift stations and improvements to the Slough Pumping building. Staff is willing to handle the improvements at the Slough with our own people.
