Re: Purchase piping for Bond Lift Station

INTRODUCTION: As part of the renovation of the Bond and Schley Lift Stations, the valves and piping need to be replaced as well as a meter installed. The two lift stations are identical and the city purchased all of the needed components for Schley about four years ago. Our staff at the WPCP anticipated replacing the piping when time allowed. Because of the plant renovation and also adding dredging to our work load, this task has not been accomplished. We are planning to include the labor for installation as part of the contract of the renovation of the lift stations.

BACKGROUND: Since both lift stations are the same and we have a detailed list of the piping, valves, and meter needed for the project we feel it is to our advantage and a cost savings to order these materials through the city and have them available for the contractor to install. That allows us to have exactly what is needed and not pay a mark up to a contractor. We have received two quotes for these materials as follows:

Zimmer Franceson, Inc.--- Moline, IL	\$14,797.00
Jim Jolly Sales, Inc.—Huntley, IL	\$16,354.30

RECOMMENDATION/RATIONALE: Staff recommends the city accept the low quote of \$14,797.00 from Zimmer Franceson. Please include this item on the council agenda on June 7, 2012 for their approval. There is \$300,000 budgeted for the total renovation of these two lift stations and the building at the Slough. The Slough building will be improved with staff at a cost of \$10-\$20K. The total estimated cost for the project including engineering and this piping is approximately \$220,000. We will also need a meter for the Bond Lift Station which will be around \$4,500.
