

Muscatine County Board of Supervisors
Monday, October 28, 2013

The Muscatine County Board of Supervisors met in regular session at 7:00 P.M. with Furlong, Howard, Sorensen, Sauer and Kelly present. Chairperson Sorensen presiding.

On a motion by Kelly, second by Furlong, the agenda was approved as written. Ayes: All.

On a motion by Howard, second by Sauer, claims dated October 28, 2013 were approved in the amount of \$703,835.44. Ayes: All.

On a motion by Kelly, second by Howard, the Board authorized the Chairperson to execute a Governor's Traffic Safety Bureau Impaired Driving Countermeasures Grant Contract in the amount of \$22,070.00. Ayes: All.

On a motion by Furlong, second by Kelly, the Board approved Resolution #10-28-13-01 Suspending the Collection of Taxes. Roll call vote: Ayes: All.

On a motion by Howard, second by Sauer, minutes of the Monday, October 21, 2013 regular meeting were approved as written. Ayes: All.

No correspondence was noted.

Kelly attended a Bi-State Drug & Alcohol Consortium meeting October 22nd.

Kelly and Sorensen attended a Bi-State Regional meeting October 23rd.

Sauer attended a Muscatine County Fair Board meeting October 22nd.

Furlong spoke to Leadership West Liberty about County government on October 24th.

Discussion was held regarding possible demolition of the Old Jail/Sheriff's Quarters. Budget Coordinator Sherry Seright presented the following bids: Sulzberger Excavating - \$85,000 (December 31, 2013 Completion Date); and Dickey Farms Excavating - \$138,750 (April 30, 2014 Completion Date). Furlong stated the future of the building has been discussed for several years during which it has been relatively empty and would cost a lot of money to renovate. Furlong stated it is time to move forward with demolition of the building. Sorensen stated the County has not found a good productive use for the building. Sauer stated if you have not found a use for it in nineteen years, you do not need it and the cost would be substantial to renovate it. On a motion by Furlong,

second by Howard, the Board accepted a bid from Sulzberger Excavating for the Old Jail/Sheriff's Quarters Demolition Project in the amount of \$85,000. Ayes: Furlong, Howard, Sorensen and Sauer. Nay: Kelly.

On a motion by Kelly, second by Sauer, Tom Harper was appointed to the Muscatine County Zoning Commission to fill a 5-year term ending November 7, 2018. Ayes: All.

On a motion by Howard, second by Kelly, the Board adopted the following 2013 Holiday Schedule for Muscatine County. Ayes: All.

On a motion by Howard, second by Furlong, the Board accepted a tentative agreement for July 1, 2013 through June 30, 2016 regarding the Muscatine County Secondary Roads Department between Muscatine County and Chauffeurs, Teamsters & Helpers, Local Union #238. Ayes: All.

Sauer stated that a commercial business property tax credit is available for businesses, but they need to file a form through the Assessor's Office in order to take advantage of the property tax credit.

Kelly stated that the Muscatine Network Consortium is having a Communitywide Information Fair at MCC tomorrow from 1:30 P.M. – 2:00 P.M. with 37 agencies represented.

Furlong thanked Muscatine Journal Reporter Mike Ferguson for doing an excellent job covering the Board of Supervisor meetings for the last 3 1/2 years and wished him good luck in his future endeavors.
