DEED

A PART OF CHARLES STREET ADJACENT TO LOT 16 IN BLOCK 2 OF THE GARDEN ADDITION TO THE CITY OF MUSCATINE, MUSCATINE COUNTY IOWA. BEGINNING AT THE NORTHWEST CORNER OF LOT 16; THENCE SOUTH 00°51'41" WEST 134.21 FEET ALONG THE WEST LINE OF LOT 16; THENCE NORTH 55°31'05" WEST 17.10 FEET; THENCE NORTH 00°51'41" EAST 26.29 FEET; THENCE NORTH 04°14'36" EAST 99.22 FEET; THENCE SOUTH 84°58'01" EAST 6.67 FEET TO THE POINT OF BEGINNING. CONTAINING 1474 SQUARE FEET.

Exempt from transfer tax per Iowa Code Section 428A.2 (6).

The City covenants with the grantees, its successors and assigns, to warrant and defend the real property against the lawful claims of all persons claiming by, through, or under the City.
