Re: Request to Extend Audit Agreement with McGladrey LLP

**Introduction and Background:**

In March of 2009 the City entered into an agreement with McGladrey LLP for audit services for a five year period from fiscal year 2008/2009 through 2012/2013. The recently completed audit was the last of the original five years for that agreement.

**Requested Extension of Audit Agreement:**

City staff asked McGladrey LLP for a proposal for a one year extension to the current audit agreement. This was primarily due to the change in financial software midway through fiscal year 2013/2014. Potential new audit firms would need to review processes under both software systems as well as the conversion. With McGladrey's already being familiar with the previous software, it is expected they could focus more on the new system and the conversion of data from the old software. McGladrey's proposal for the one year extension is \$45,400. This is the same amount as the recently completed 2012/2013 audit.

The Audit Committee reviewed this request at their meeting on December 12, 2013 and is recommending that the one year extension be approved.

**Summary:**

Please include this request to extend the audit agreement to include the year that will be ending June 30, 2014. The extension proposal from McGladrey's is attached. Please contact me if you have any questions or need additional information.
