INTRODUCTION:

A list of vehicles and equipment is submitted for council action to declare as surplus property.

BACKGROUND:

Prior to 2009 the City of Muscatine held public auctions every other year to dispose of surplus equipment. We started using Public Surplus in June 2009 and have held many auctions since then.

RECOMMENDATION/RATIONALE:

The Public Surplus option has proven to be very successful. The City's Public Works staff recommends declaring the equipment and vehicles as sent to the City Administrator surplus property for disposal. This list includes buses replaced with the DERA Grant, an old squad car and Transfer Trailer from the Transfer Station.

Listed below is the information on four transit buses to be declared as surplus vehicles at the March 6, 2014 City Council meeting.

5211-40-5211 – #238 - 2004 Ford/Goshen Transit Bus – VIN# - 1FDXE45P14HA91635 – miles – 227,144 - Bus may have a possible antifreeze leak.

5211-40-5211 - #239 – 2004 Ford/Goshen Transit Bus – VIN # - 1FDXE45P84HA91633 – miles – 239,191 - Transmission is out of bus.

Both #238 & #239 were listed with the IDOT for thirty days (30) as required. There was no interest in them on that website.

The next two buses were replaced with buses purchased with money from the DERA Grant. They will also be listed for thirty days (30) on the IDOT website. Both engines will be disabled. If there is no interest for them on that site, they will also be offered for sale on the Public Surplus website.
