Re: Resolution Approving Final Acceptance & Close-out of Security Gate and Camera Improvements Project #9I140MUT100

INTRODUCTION: The City of Muscatine accepted a grant agreement with the Iowa DOT to provide funding for the project identified as No. #9I140MUT100 "Security Gate and Camera Improvement Project".

BACKGROUND: Following the preparations of plans and specifications, the Project was bid and a contract was awarded to FSS, Inc of Illinois City, IL in the amount of \$79,136.00. The project consisted of a new security gate with swipe card access and high resolution video surveillance, located on the south access road from the National Guard Armory. The Project was completed in July 2014. One change order resulted in a \$24,741.00 reduction, bringing the project total to \$54,395.00. \$40,796.25 was paid previously. Final payment of \$10,879.00 is now due, with \$2,719.75 in retainage to be released 30 days after approval of the resolution.

RECOMMENDATION/RATIONALE: On July 30, 2014, the City was notified by the project engineer from Anderson-Bogert Engineers and Surveyors that all work has been completed and is ready for final acceptance by the City. It is recommended that the City Council take action to approve the attached resolution accepting final work and authorizing the final payment to FSS, Inc. for the work performed on Security Gate and Camera Improvements Project #9I140MUT100.

WHEREAS, the City of Muscatine approved the Plans, Specifications, and Form of Contract for IDOT Project No. 9I140MUT100 – Security Improvements: Gate and Camera for the Muscatine Municipal Airport.

WHEREAS, the City of Muscatine entered into a contract for said project with FSS, Inc. for \$79,136.00 with one (1) change order of (\$24,741.00) for a total of 54,395.00; and

WHEREAS, the City of Muscatine previously made one (1) payment of \$40,796.25 to FSS, Inc. for work completed; and

WHEREAS, work under said contract has been completed by FSS. Inc., and approved and accepted by Anderson-Bogert Engineers & Surveyors, engineers for the City as having met the requirements of the Plans and Specifications adopted by this Council; and

WHEREAS, the amount of \$10,879.00 is now due and payable to FSS. Inc., leaving a retainage of \$2,719.75 which is due and payable to Muscatine Bridge Co. Inc., thirty (30) days of approval of this Resolution,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MUSCATINE, IOWA, that the City hereby accepts all work under the IDOT Project No. 9I140MUT100, T-Hangar Apron Drainage Project and hereby authorizes that payment be made to FSS., Inc., for \$10,879.00.

BE IT FURTHER RESOLVED that the final retainage payment of \$2,719.75, which represents 5% of project total, be paid to FSS., Inc., thirty (30) days from the date of the adoption of this Resolution.
