RE: Request Approval of Purchase Order for the Phase I – Waterslide Restoration and Maintenance Project

INTRODUCTION:

Please accept this memo as a request for the Muscatine City Council to approve a Purchase Order for the Phase I – Waterslide Restoration and Maintenance Project as requested and approved in the FY 2013-14 Swimming Pools Budget.

BACKGROUND:

The requested service as detailed in the attached Project Request for Proposal is to provide a high level restoration and maintenance to the five (5) water slides at the Muscatine Aquatic Center. The facility is in its tenth year of operation and this maintenance task is necessary in order to keep long term high maintenance costs down.

RECOMMENDATION:

The City's Purchasing Policy was used to solicit for qualified responsive and responsible vendors to submit proposals as requested.

A total of seven (7) proposals were sent out to perspective vendors. We received one (1) proposal back from SlideCare LLC in the amount of \$11,035.00. Reference checks were conducted and the vendors Certificate of Insurance is on file.

At this time, the City Staff would recommend that the City Council approve a purchase order in the amount of \$11,035.00 to SlideCare LLC from Avon, OH for the Phase I – Waterslide Restoration and Maintenance Project.

The FY 2013-14 budget had \$31,000.00 approved for this project.

Scope of Services
Phase I – Waterslide Restoration and Maintenance Project

Submittal Requirements:

All proposals should contain the following information and any other information deemed pertinent to adequately represent the Vendor.

1. Examples and a brief summary of comparable projects including recent clients to be contacted for references.
2. Qualifications of key professional and technical staff including their availability on the project.
3. Qualifications and availability if needed of any sub-contracted professional and technical staff.
4. Designation of the project manager who will be the key contact person.
5. Provide an estimated timeline to complete the requested professional services.
6. Provide not-to-exceed itemized costs to complete the required services.

Requested Project Services:

- a. Perform interior restoration and maintenance to the five (5) main waterslides at the Muscatine Aquatic Center. The slides are eleven years old and are as follows:
 1. Two (2) tube drop slides, 32" opening, and 19' long
 2. Family slide, 8' wide, and 36' long
 3. Open flume slide, 42" opening, and 137' long
 4. Enclosed slide, 32" opening, and 140' long
- b. Repair any chips, scratches, weak areas, or other substantial interior blemishes.
- c. Re-caulk of all slide seams using either sikaflex 291 or 3M 4200
- d. Cleaning and polishing of interior gelcoat.
