Re: Resolution to Award Contract for the Dredge Line Mad Creek Extension Project

INTRODUCTION: The City of Muscatine Water Pollution Control Plant received bids on the Dredge Line Mad Creek Extension project on February 26th, 2015.

BACKGROUND: The engineer's estimate for the project was \$133,850. \$90,000 was budgeted for the project. The low bid was received from Sulzberger Excavating for \$75,000.00. Engineering costs of \$15,850.00 and bridge supports purchased by the City for \$16,912.00 brings total project cost estimates to \$107,762.00.

RECOMMENDATION/RATIONALE: Staff recommends awarding the Dredge Line Mad Creek Extension Project to Sulzberger Excavating for \$75,000.00.
