SUBJECT: Proposed New Ambulance Service Fee Schedule

INTRODUCTION:

The Muscatine Fire Department Ambulance Service Fee Schedule is reviewed annually and discussed during our budget sessions. Rates are reviewed through an annual rate survey of ambulance providers in Iowa along with reviewing Wellmark annual payment updates. Since Wellmark Blue Cross and Blue Shield have increased what they will pay for reimbursement it is advised we modify our rates to be in line with their reimbursements.

BACKGROUND:

Ambulance charges are reviewed annually and changed in accordance with Wellmark's Maximum Allowable Fee (MAF). The last Muscatine Fire Department Ambulance rate changes occurred in July of 2014. Wellmark advised us that their new rates will go into effect on July 1, 2015, which means that we are allowed to change our rates in accordance with their new fees. If we don't change our rates to be in line with their new fees, in essence we will be missing out on potential revenue that they are willing and obligated to pay as a network provider.

RECOMMENDATION/RATIONALE:

The Muscatine Fire Department recommends changing our Ambulance Fee Schedule in accordance to Wellmark's new Maximum Allowable Fee for ambulance charges effective July 1, 2015.
