A. Resolution Accepting Easements for the Musser Park to Wiggins Road Trail Project

Presented for City Council's consideration is a resolution accepting easements for the Musser Park to Wiggins Road Trail Project. Approval of the easement agreement, which covers the route of the trail between 33rd Street and 41st Street, will complete the process of acquiring all the necessary property and easements needed to construct this project. Approval of the easement will allow for construction to proceed this spring.

B. Resolution Accepting Easements for the Mulberry Avenue from Palms Drive to Houser Street Reconstruction Project

Presented for City Council's consideration is a resolution accepting easements for the Mulberry Avenue from Palms Drive to Houser Street Reconstruction Project. This project design work is essentially complete and the city needs temporary construction easements from most of the adjoining property owners. The total number of easements required is 26, and the total cost for the easements is \$1,500.

C. Resolution Awarding Bid and Approving Contract and Bond for the Muscatine Slough Rip-Rap Project

Presented for City Council's consideration is a resolution awarding the bid and approving the contract and bond for the Muscatine Slough Rip-Rap Project. Seven bids were submitted for this project with the lowest responsible bid from Brauns Excavation in the amount of \$39,627. There are several items in the project that will be done by Public Works and Parks and Recreation staff.

Presented for City Council's consideration is a resolution setting a public hearing on the plans, specifications, form of contract, cost estimate and setting the bid opening date for the Muscatine Art Center HVAC Replacement and Miscellaneous Window Renovations Project. HVAC system upgrades will begin in the Stanley Gallery, link, Musser House, and Carriage House, and miscellaneous window renovations will begin as well. Prior to any formal action by City Council, a public hearing is required.

E. Resolution Approving Contract and Bond for the Clark House Domestic Water Heater Replacement Project

Presented for City Council's consideration is a resolution approving the contract and bond for the Clark House Domestic Water Heater Replacement Project. The bid for this project was awarded to JL Brady in the amount of \$49,478 at the February 4, 2016 City Council meeting. It is now necessary to approve the contract and bond for the project. Project costs will be paid through the Public Housing Capital Fund Program.

F. Resolution Authorizing Assessment of Unpaid Abatement Costs and Unpaid Rental Inspection Fees to Private Properties

Presented for City Council's consideration is a resolution authorizing the assessment of unpaid abatement costs and unpaid rental inspection fees to private properties. Periodically the city takes action to assess unpaid nuisance abatement costs and rental inspection fees to private properties. The fee being requested for assessment at this time totals \$18,727.44.

G. Resolution Accepting Completed Work for the Cedar Street Traffic Signal Project

Presented for City Council's consideration is a resolution accepting completed work for the Cedar Street Traffic Signal Project. Funds were secured for this project from the Traffic Safety Fund in an estimated amount of \$138,000. MP&W designed and constructed the signals and completed their work on August 14, 2015. The final accounting of the project from MP&W is \$127,723. Once the city receives funding from the State of Iowa from the Traffic Safety Fund, the city will reimburse MP&W for their project costs.

H. Request to Approve Conversion of 2nd Street from a One-Way to a Two-Way Reconfiguration

Presented for City Council's consideration is a request to approve the conversion of 2nd Street from a one-way to a two-way reconfiguration. The city has evaluated converting 2nd Street between Pine Street and Mulberry Avenue from a one-way to a two-way configuration for the Mississippi Drive Corridor Project. Furthermore, following the completion of the Mississippi Drive Corridor Project, 2nd Street will remain a two-way street. Following multiple public meetings, the overall response

has been to keep 2nd Street as a two-way street.
