

A. Proposed Application for State and Federal Transit Funding

This public hearing concerns the submission of a proposed application for state and federal transit funding. Annually, the city is required to submit an application to the Iowa Department of Transportation to request state and federal transit funds. A. First Reading of RAGBRAI Ordinance

Presented for City Council's consideration is the first reading of a RAGBRAI Ordinance. This ordinance is temporary in nature and will not be printed as part of the City of Muscatine's Code of Ordinances. The provisions of this ordinance shall be in

effect upon passage by City Council and will remain in effect until 5:00 p.m. on July 31, 2016.

**B. Resolution Awarding Contract for the Muscatine Art Center/Museum HVAC Replacement and Miscellaneous Window Renovations Project**

Presented for City Council's consideration is a resolution awarding the contract for the Muscatine Art Center/Museum HVAC Replacement and Miscellaneous Window Renovations Project. One bid was received for the project. It is recommended the base bid and Alternates #1 and #3 in the amount of \$1,590,520 be awarded to Crawford Company. The Art Center Board of Trustees is seeking funds for Alternates #2 and #4 which total \$147,075. The contractor has agreed to hold the costs for these two alternates until September 1, 2016 subject to the Art Center Board of Trustees securing funding for them.

**C. Resolution Accepting Dedication of Right-of-Way and Public Street Improvements to Extension of Sevig Street**

Presented for City Council's consideration is a resolution accepting the dedication of right-of-way and public street improvements to the extension of Sevig Street. Wal-View Developments LLC has submitted a request for the City of Muscatine to accept an extension to Sevig Street, a publically maintained street, and to accept the dedication of a small amount of right-of-way needed for this extension of Sevig Street. This extension meets all of the City of Muscatine's applicable standards.

**D. Resolution Approving the Official Pay Plan for Non-Union Employees Effective July 1, 2016**

Presented for City Council's consideration is a resolution approving the official pay plan for non-union employees effective July 1, 2016. The proposed pay plan includes a request to remove the Health and Housing Coordinator position and also applies the budgeted 2.75% across-the-board increase to all pay grades.

**E. Resolution Approving Mortgage Release Under the 2009 Community Development Housing Rehabilitation Program for 312 Green Street**

Presented for City Council's consideration is a resolution approving a mortgage release under the 2009 Community Development Housing Rehabilitation Program for 312 Green Street. The property owner entered into a five-year forgivable loan in the amount of \$24,999 on May 21, 2011. The loan term ends on May 18, 2016. The property owner passed away on September 2, 2015, and her son would like to sell the property. Staff is recommending City Council take action to release the mortgage to allow the sale to move forward.

**F. Resolution Accepting Completed Work for the Muscatine Slough Rip-Rap Project and Authorizing Final Payment**

Presented for City Council's consideration is a resolution accepting completed work for the Muscatine Slough Rip-Rap Project and authorizing final payment. The contract for this project was awarded to Brauns Excavating on February 18, 2016 in the amount of \$39,627. There was one change order resulting in a deduction of \$1,376 for a final contract price of \$38,251. Staff is recommending the acceptance of the work completed for the project and authorizing final payment to the contractor.

**G. Resolution Setting Public Hearing to Declare Property at 1202 Indiana Street as Surplus Property**

Presented for City Council's consideration is a resolution setting a public hearing to declare property at 1202 Indiana Street as surplus property. This property was acquired by the City of Muscatine in 2014 for back taxes. Since that time, the city has been maintaining the property through the nuisance abatement program. Prior to declaring this property as surplus, a public hearing is required. This hearing will take place on Thursday, April 21, 2016, at 7:00 p.m.

**H. Resolution Setting Public Hearing to Declare Property at 1111 Nebraska Street as Surplus Property**

Presented for City Council's consideration is a resolution setting a public hearing to declare property at 1111 Nebraska Street as surplus property. This property was acquired by the City of Muscatine in 2014 for back taxes. Since that time, the city has been maintaining the property through the nuisance abatement program. Prior to declaring this property as surplus, a public hearing is required. This hearing will take

place on Thursday, April 21, 2016, at 7:00 p.m.

- I. Request to Approve Settlement Agreements for Violation of Iowa Code Section 453A.2 (Selling Tobacco to a Minor)

Presented for City Council's consideration is a request to approve settle agreements for violation of Iowa Code Section 453A.2 (selling tobacco to a minor). Settlement agreements were received from Casey's General Store #1484 and Wholesale Food Outlet #312. The civil penalty of \$300 has been paid by each store.

- J. Request to Approve Professional Services Agreement for Update of the Master Plan for Riverside Park

Presented for City Council's consideration is a request to approve a professional services agreement for the update of the Master Plan for Riverside Park. The timing of this update is ideal as it will dovetail with the upcoming Mississippi Drive Corridor Project. The engineering firm of Short Elliott Hendrickson Inc. (SEH) has submitted a proposal for the Master Plan update in the amount of \$40,000. Using the resources of SHE coupled with Bolton-Menk (MDCP), the city will be establishing a well-conceived and well-designed plan for the Central Business District. It is staff's recommendation the professional services agreement with SEH be approved.

- K. Request to Authorize Letter of Opposition to the Annexation of Certain City Property by Joint Drainage District #13

Presented for City Council's consideration to authorize a Letter of Opposition to the annexation of certain city property by Joint Drainage District #13 (JDD#13). Completion of this annexation would make all property in the proposed addition liable for annual drainage assessment. Because the potential impacts of the proposed annexation could be quite significant and a lack of information from JDD#13, staff is recommending City Council direct a Letter of Opposition be prepared with legal advice from the City Attorney and submitted to JDD#13 prior to the April 15<sup>th</sup> deadline/public hearing.
