Re: Resolutions to Set Public Hearings on Declaring 303 Brook Street & 307 Brook Street as Surplus Property

INTRODUCTION: Staff is recommending that three City owned parcels at 303 Brook Street & 307 Brook Street be declared as public surplus.

BACKGROUND: The City owns a vacant 7,321 sq. ft. parcel located at 303 Brook Street and a vacant and a 8,605 sq. ft. parcel at 307 Brook Street. Staff has determined that there is no public purpose for the continued City ownership of these three parcels, and is recommending that City Council declare them as surplus process, which would be the first step in returning these parcels to productive use and the tax roll. Currently Parks and Recreation Department staff is mowing these three parcels and shoveling snow on the adjoining sidewalks. Between these costs and the property tax that is not being collected on these parcels it is costing the City about \$2,400 per year to continue to own these two parcels.

The City first acquired the Brook Street parcels in 1984 and also in 1984 the City demolished a house on this site, in 1993 the City subdivided the two Brook Street Parcels with aim of making two site available for the development of affordable homes.

The attached resolutions setting a public are the first actions that need to be taken to do this. Discussion on the sale procedure and price will occur at a future meeting of Council.

RECOMMENDATION: To approve the attached resolutions.


