**RE:** Approval of 2017 Annual Plan and Capital Fund Annual Statement and Authorization for Mayor to Sign the *PHA Certification of Compliance with the PHA Plans and Related Regulations including Civil Rights and PHA Plan Elements that Have Changed and Civil Rights Certification*

**INTRODUCTION:** The Public Housing Agency (PHA) is required to prepare and adopt an Annual Plan prior to each operating year. A 45 day public comment period including a public hearing is required prior to adoption of the Annual Plan and revisions to funding available in the Capital Fund Program Annual Statement.

**BACKGROUND:** The Housing and Economic Recovery Act of 2008 exempted qualified PHAs (those agencies with less than 550 total units and not designated as troubled) from the necessity of submitting an Annual Plan. These agencies are still required to complete the planning and community input processes, including the public comment period and public hearing, and submit a completed *Civil Rights Certification* (HUD form 50077-CR).

The required public comment period for the proposed annual plan and revised capital fund annual statement began March 4 and will conclude upon completion of the April 21 public hearing. The Plan has been available for review throughout this time; no comments were received. The Housing Agency is also required to consult with the Resident Advisory Board (RAB) as part of the comment period. A RAB meeting was conducted March 22, and no comments were received.

**RECOMMENDATION / RATIONALE:** It is recommended the City Council, acting as the Board of Commissioners for the Muscatine Municipal Housing Agency, approve the attached 2017 Streamlined Annual Plan (HUD-50075-SM) and Capital Fund Annual Statement (HUD-50075.1) and authorize the Mayor to sign the required PHA Certification of Compliance with the *PHA Plans and Related Regulations including Civil Rights and PHA Plan Elements that Have Changed and Civil Rights Certification*.

**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

**Applicability.** Form HUD-50075-SM is to be completed annually by **Small PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, HCV-Only PHA, or Qualified PHA do not need to submit this form.

**Definitions.**

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.

- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

<b>B.3</b>	<p><b>Progress Report.</b></p> <p>Provide a description of the PHA's progress in meeting its Mission and Goals described in the PHA 5-Year Plan.</p> <p><b>Goal: Improve the Quality of assisted housing while managing resources.</b>  MMHA has maintained a 99% occupancy and 100% utilization in the Public Housing and Housing Choice Voucher programs, respectively. Maintenance completes work orders in less than 14 hours on average. Staff is evaluating the biennial inspection process for opportunities to improve outcomes for clients.</p> <p><b>Goal: Use assisted housing as a platform for improving self-sufficiency and quality of life.</b>  MMHA continues to partner with the United Way, Muscatine Center for Strategic Action, Muscatine Community School District, and Muscatine County Community Services to coordinate services to improve efficiencies and outcomes for families and the community. Staff continues to evaluate new partnerships that would enhance the quality of life in our complexes or for those receiving rental assistance. We are in the process of reviewing all FSS policies and procedures to insure the effectiveness of services and utilization of resources. The PCC is being reconfigured to maximize community resources and develop a sustainable approach to service provision. In addition, significant effort is going into increasing FSS participation by public housing residents, especially families living at Sunset Park.</p> <p><b>Goal: Adapt Programs to Muscatine County's changing housing environment, and to drive employment, education and social service opportunities for tenants.</b>  Staff is working with internal and external partners to insure clients are provided quality living options. The Housing Administrator regularly attends the Muscatine Landlord Association meetings and has given a presentation on the Section 8 Housing Choice Voucher Program and begun the discussion of how to strengthen the partnership between landlords and the Agency. Council approved the award of Project-Based Vouchers to two developers applying for Low Income Housing Tax Credits (LIHTC) through the Iowa Finance Authority. One project was awarded LIHTCs and will now begin the underwriting process. The project will provide 55 two- to four-bedroom units for families in the community with occupancy anticipated to begin late 2017. MMHA also intends to renew the contract for 12 project-based vouchers in an existing property for individuals with disabilities.</p>

In late 2015, the Agency Board approved the allocation of a total of 25 PBVs to two potential new construction projects to support efforts to secure an award of LIHTC. Harrison Lofts, a project by MV Residential Development LLC, was allocated LIHTCs to develop 52 units near the intersection of Bandag Drive and Colorado Street in Muscatine. The project will target families at or below 50% of the area median income and upon HUD approval will include 13 PBV units. This area is near the main shopping district of the community and will provide much needed quality, affordable living opportunities to the many service workers in the area. There are no other affordable housing developments in this section of town. The second project will have to reapply for PBV if it proceeds at a later date. The use of PBV allows MMHA to further efforts to improve access to higher quality housing throughout the community.</p> <p>(d) The PHA must submit its Deconcentrating Policy for Field Office Review. 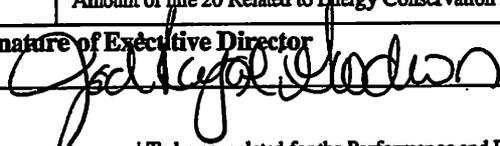
