Re: Resolution approving the contract and bond related to the Muscatine CDBG Downtown Revitalization Stormwater Project.

Introduction & Background:

The City of Muscatine received and accepted a grant from the Iowa Economic Development Authority to complete a downtown revitalization project. The City of Muscatine entered into a contract with HBK Engineering for engineering services to design, prepare plans, specifications, bid documents, and construction oversight for the CDBG Downtown Revitalization Project. Bids were opened on February 11th with two bids received from Triple B Construction and Miller Trucking and Excavating. Both bids were over the engineer's estimate of \$52,000. Triple B was the low bidder in the amount of \$69,558.

City staff have met with Triple B and investigated how to reduce the cost of the improvements while still achieving the scope of the project by managing stormwater runoff from buildings using green sustainable stormwater infiltration practices. Triple B has verbally committed to work with the City of Muscatine to approve deductive changes orders to adjust design and quantities to bring the project within budget.

RECOMMENDATION/RATIONALE: It is recommended that City Council approve the attached resolution approving the contract and bond related to the Muscatine CDBG Downtown Revitalization Stormwater Project with Triple B Construction Corp.
