### INTRODUCTION:

The IOWA DOT has received bids and done bid tabs for the project and the results are attached. The IowaDOT letting was today at 10:00 AM.

### BACKGROUND:

The engineer's estimate for this project is \$2,370,000.00 which does not include a contingency. Four bids were received and the apparent low bid is shown below.

1. Langman Construction Inc.	\$1,888,269.94

The bid has been reviewed by the IowaDOT and Shoemaker-Halland.. It does not appear that the unit prices are unbalanced or unresponsive and no exclusions are listed. The DOT must release the information that they are the low bidder and no problems were found but once the DOT releases this information the City would like to proceed as quickly as possible towards contracts and a notice to proceed.

Langman Construction Inc. has successfully performed on Muscatine projects in the recent past. The City Project Management staff is satisfied with the work this contractor has done on other projects and recommends approval of this contract. Hopefully more information will be available by the Thursday Council meeting and can be shared at that time.

### RECOMMENDATION/RATIONALE:

The city engineer recommends awarding the Mulberry Reconstruction Project to Langman Construction Inc. for \$1,888,269.94. Contingent upon the Iowa DOT finding their bid to be a responsive bid.
