INTRODUCTION: On March 10, 2016, the Council was presented with an in-depth review of vacant and abandoned or neglected properties in the City.

BACKGROUND: Over the last two decades, the Community Development Department has accumulated a significant number of properties, some vacant and some are neglected. We are looking to City Council to declare the listed properties as surplus. Staff will create an exclusion list of those properties that may be beneficial to maintain.

RECOMMENDATION: Staff is requesting Council approve a Resolution to declare the listed vacant properties as surplus and to allow staff to dispose of them in the best possible way. Our Staff will, of course, present any and all offers should we dispose of property to Council.
