Enclosed are copies of the Abstract of Election for the City Election held last week. Certificates of Elections and a copy of the Iowa Open Meetings Open Records Handbook were mailed to each winner. Their term of office begins, and they must be sworn in, by January 2, 2018 unless they were elected to fill an unexpired term, in which case, they shall be sworn in by November 24, 2017. They were told to contact their City Clerk to schedule their oath of office.

If a winner was determined by write-in votes, they were told to contact their City Clerk by Friday, November 24, 2017 in writing if they were declining the position. If this happens, then the next highest vote getter should be contacted to see if they will accept the position. The aforementioned is only the case with write-in winners that decline. If a winning candidate who officially had their name on the ballot declines, the position is considered vacant.
