RE: Resolution to set public hearing date for the 2019 Annual Plan

INTRODUCTION: Per regulation a public comment period including a public hearing is required prior to adoption of the Annual Plan and policy amendments. A minimum 45-day notice must be given prior to a public hearing. It is proposed the public hearing be set for April 5 at 7:00 p.m.

BACKGROUND: Under Federal regulations qualified public housing authorities (PHAs), including the Muscatine Municipal Housing Agency, are required to have a resident advisory board (RAB) to review PHA policies and budgets as well as to conduct an annual public hearing to receive comment on proposed goals, policy changes and the use of public funds. During the comment period the public is invited to submit remarks to the PHA. The PHA must publish a notice of the hearing and relevant information and make such information available for inspection at its principal office.

The public hearing must be part of a public comment period and noticed not less than 45 days in advance. The comment period will open February 20 and end April 5 following the public hearing.

RECOMMENDATION / RATIONALE: It is recommended the City Council set a public hearing on the 2019 MMHA Annual Plan for April 5, 2017 at 7:00 p.m.
