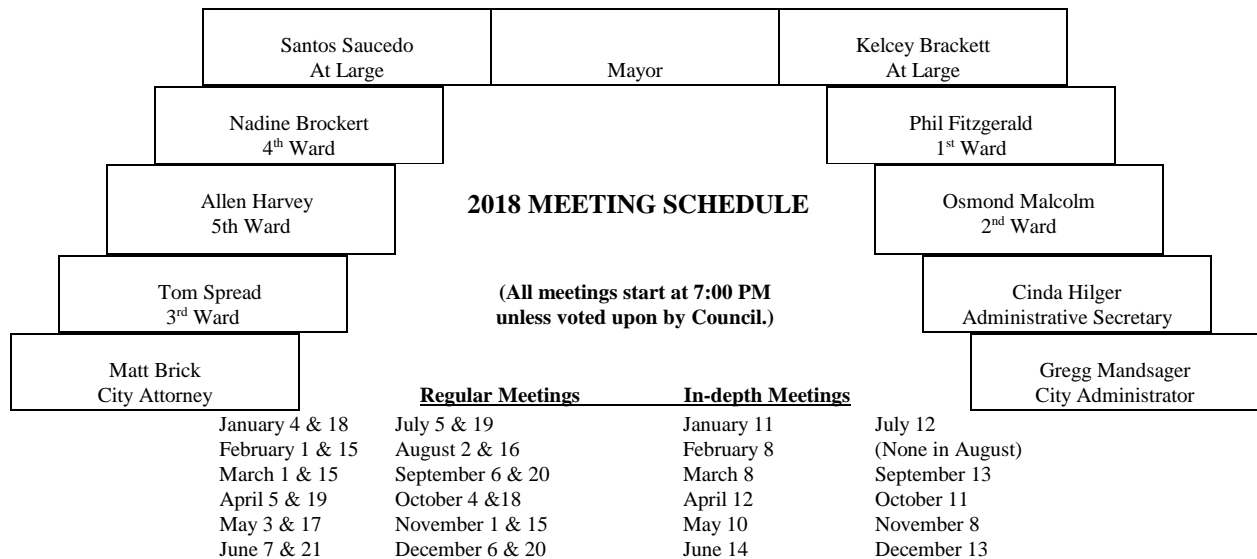

7. PUBLIC HEARING

A. Proposed Amendment to the Consolidated Muscatine Urban Renewal Area.

This public hearing concerns a proposed amendment to the Consolidated Muscatine Urban Renewal Area and designating an expanded Consolidated Muscatine Urban Renewal Area pursuant to Chapter 403, Code of Iowa, by adding and including the following recently annexed property: A tract of land located in the Northeast Quarter and the Northwest Quarter of Section 24, Township 77 North, Range 2 West of the 5th P.M., Muscatine County, Iowa. Prior

to any formal action by City Council, a public hearing is required.

Now is the time for the public to comment.

B. Proposal to Enter into an General Obligation Essential Purpose Loan Agreement

This public hearing concerns a proposal to enter into a General Obligation Essential Purpose Loan Agreement, in a principal amount not to exceed \$3,235,000, for the purpose of paying the costs, to that extent of (1) acquiring a fire truck; (2) planning, designing and constructing physical plant, apron and hangar improvements at the municipal airport; (3) improving and equipping existing municipal parks; (4) and constructing and installing sanitary sewage treatment system improvements.

C. Proposal to Enter into a General Obligation Public Buildings Loan Agreement

This public hearing concerns a proposal to enter into a General Obligation Public Buildings Loan Agreement, in a principal amount not to exceed \$570,000 for the purpose of paying the costs, to that extent, of remodeling the municipal library and the HNI Community Center and constructing building and grounds improvements for public buildings.

This fee increase will take effect July 1, 2018. The Ordinance provides that the City give Interstate Power and Light Company a minimum of 90 days' notice when implementing a change in the franchise fee rate.

F. Resolution Setting a Public Hearing on Proposed Development Agreement with White Distribution & Supply, LLC, Including Annual Appropriation Tax Increment Payments

Presented for City Council's consideration is a resolution setting a public hearing on the proposed Developmental Agreement with White Distribution. This Development Agreement would provide financial incentives to the company in the form of annual appropriation tax increment payments. Prior to any formal action by City Council, a public hearing is required. This hearing will take place on Thursday, April 5, 2018, at 7:00 p.m.

G. Resolution Authorizing the Assessment of Unpaid Abatement Costs and Unpaid Rental Inspection Fees to Private Properties

Presented for City Council's consideration is a resolution authorizing the assessment of unpaid abatement costs to private properties. Periodically the city takes action to assess unpaid nuisance abatement costs to private properties. The nuisance abatement costs for snow, junk, and weed removal total \$2,738.02. The administrative fees are \$1,425.00 and the assessment fees are \$1,500.00. The total fee being requested for assessment at this time totals \$5,663.02.

H. Resolution Approving a Sidewalk or Street Café Easement Agreement – Boonie's on the Avenue – 214 Iowa Avenue.

Presented for City Council's consideration is resolution Approving Sidewalk or Street Café Easement Agreement for Boonie's on the Avenue. Boonie's on the Avenue is proposing dining on a raised platform on two street parking spaces directly in front of the restaurant located at 214 Iowa Ave. This will be identical to the outdoor dining used last year.

I. Resolution Adopting Seasonal Pay Plan Effective April 1, 2018

Presented for City Council's consideration is a resolution adopting a Seasonal Pay plan effective April 1, 2018. This pay plan includes a request to change the pay grade for Seasonal Equipment Operator from pay grade two to pay grade three, and the pay grade for Lead Groundskeeper from pay grade four to pay grade five. The pay plan also includes updated ranges and position titles for those employees who work year-round but less than 20 hours per week.

J. Resolution Setting Public Hearing on the Disposal of Surplus Property

Presented for City Council's consideration is a resolution setting a public hearing on April 5th, 2018, regarding the disposal of city owned surplus property. The City acquired this property as part of the Mad Creek Levee Project and no longer has a need for this property. It is recommended that City Council approve the sale of the City owned property to the adjacent property owner at a price to cover expenses.

K. Request to Approve Issuance of Purchase Order in the amount of \$28,553.70 to Conference Technologies for the Purchase of Audio-Visual Equipment for the Library

Presented for City Council's consideration is a request for the issuance of a purchase order in the amount of \$28,553.70 to Conference Technologies for the purchase of Audio Visual Equipment for the library. The library requested quotes for this project and received two responses. Conference Technologies was the low bid.

Is there a motion to approve the request as submitted?

L. Request to Approve Issuance of Purchase Order in the amount of \$27,931.72 to Lucas Communications for the Purchase of Communications Service and Equipment for Library

Presented for City Council's consideration is a request for the issuance of a purchase order to Lucas Communications for communication service and equipment for the library. The library initiated bids for this project and received two responses. Lucas Communication was the low bidder at \$27,931.72.

M. Request to Purchase Tarp Machine to be used at the Landfill

Presented for City Council's consideration is a request to purchase a tarp machine to be used at the landfill. The 2017/2018 budget included \$35,000 for the purchase of a replacement tarp machine. This machine is used daily to deploy three tarps that are 30' x 100' for daily covering of trash.

N. Request to Purchase Zero Turn Lawn Mower for Airport

Presented for City Council's consideration is a request to purchase a zero-turn lawn mower to be used at the Municipal Airport. The previous lawn mower was more than ten years old and in September of 2017 caught fire, making it unusable. The airport needs a zero-turn mower to mow along the sides of the runway, around the runway lights and the front lawn area. There were 12 bids received for this purchase and after review City Tractor Co. was the lowest bidder that met the accepted options. The bid total price is \$9,746.50, which is under the budgeted \$10,100. It is staff's recommendation to authorize the issuance of a purchase order to City Tractor Co. in the amount of \$9,746.50.

O. Request to Approve Federal Opportunity Zone Designation

Presented for City Council's consideration is a request to approve certain areas of Muscatine as Opportunity Zones. This would allow the city to offer incentives for development in the Opportunity Zone by offering tax benefits in addition to our current programs.

P. Request to approve professional services agreement with Impact 7G for the assessment and evaluation of asbestos for the two properties located at 507 and 515 East 2nd Street.

Presented for City Council's consideration is a request to enter into a professional services agreement with Impact 7G for the assessment and evaluation of asbestos at two properties located at 507 and 515 E. 2nd Street. Impact 7G is recommended because of their extensive experience with this project. A fee has been negotiated for the amount of \$15,800.

Q. Request for approval of professional services agreement with Martin and Whitacre for

the West Hill Sewer Separation Phase Four Staking and Record Drawing

Presented for City Council's consideration is a request to enter into a professional services agreement with Martin & Whitacre for the construction staking and as built drawings for Phase 4 of the West Hill Sewer Separation Project. Martin & Whitacre has performed these services for the City in the past and the city has been very satisfied with the work done. A fee of \$50,000 has been negotiated for this project.

R. Request for Setting the Week of Spring Clean Up Week for April 23-27, 2018

Presented for City Council's consideration is a request to approve Public Works setting the dates for Spring Clean Up Week for April 23-27, 2018. The following changes were made to Spring Clean Up Week in 2017: Electronic waste and tires will no longer be picked up curbside. Electronic waste and up to eight tires will be accepted from Muscatine residents at the transfer station.
