**INTRODUCTION:**

The City of Muscatine Public Works Department has compiled a list of alleys to be asphalt overlaid during Fiscal Year 2019. Bids were received on July 27, 2018.

**BACKGROUND:**

The City of Muscatine Roadway Maintenance Division has compiled a list of alleys that qualify for asphalt overlay using a matrix previously developed. Bids were received on July 27, 2018. The bids were tabbed and evaluated. The lowest responsible bidder for the project was Taylor Ridge Construction. This contract is an indefinite delivery, indefinite quantity contract. This contract will be modified as needed to fit within the budget set for it.
