

Muscatine County Board of Supervisors
Monday, October 15, 2018

The Muscatine County Board of Supervisors met in regular session at 9:00 A.M. with Howard, Mather, Sorensen and Bonebrake present. Sauer was absent. Vice-Chairperson Mather presiding.

On a motion by Sorensen, second by Bonebrake, the agenda was approved as written. Ayes: All.

On a motion by Howard, second by Sorensen, the Board waived the third reading and approved Ordinance #10-15-18-01 Amending the Muscatine County Zoning Ordinance Related to Telecommunications Transmission Towers as a Special Permitted Use in A-1 Agricultural Districts, R-1 Residential Districts, I-1 Light Industrial Districts and I-2 Heavy Industrial Districts on the second and final reading. Roll call votes: Ayes: All.

On a motion by Sorensen, second by Bonebrake, the Board approved an agreement with Iowa DOT, Agreement No. 5-18-HBP-SWAP-025, for utilization of SWAP funds on a bridge project on North Isett Avenue over Mosquito Creek. Ayes: All.

On a motion by Sorensen, second by Bonebrake, the Board approved an agreement with Iowa DOT, Agreement No. 5-18-HBP-SWAP-026, for utilization of SWAP funds on a bridge project on F70 (155th Street) over an unnamed creek. Ayes: All.

County Engineer Keith White updated the Board on secondary road projects.

On a motion by Howard, second by Bonebrake, minutes of the October 8, 2018 regular meeting were approved as written. Ayes: All.
