

Muscatine County Board of Supervisors  
Wednesday, November 14, 2018

The Muscatine County Board of Supervisors met in special session with Howard, Mather, Sauer and Sorensen. Bonebrake was absent. Chairperson Sauer presiding.

On a motion by Howard, second by Sorensen, the agenda was approved as presented. Ayes: All.

County Auditor Leslie Soule filed the 2018 General Election Post-Election Audit and Auditor Certification with the Board stating Fruitland Two/Lake was the precinct audited and the results of the audit matched the results on election night.

The Board met as a Board of Canvassers for the General Election held on Tuesday, November 6, 2018. The Board certified the following to be a true and correct abstract of the votes of the election. There were a total of 15,111 ballots cast as follows:

**FOR UNITED STATES REPRESENTATIVE-DISTRICT 2** – 14,794 total votes were cast: Christopher Peters received 6,569 votes, Dave Loebsack received 7,797 votes, Mark David Strauss received 327 votes, Daniel Clark received 98 votes and there was a scattering of 3 votes.

**FOR GOVERNOR AND LIEUTENANT GOVERNOR** – 14,981 total votes were cast: Kim Reynolds/Adam Gregg received 7,535 votes, Fred Hubbell/Rita R. Hart received 7,081 votes, Jake Porter/Lynne Gentry received 266 votes, Gary Siegwarth/Natalia Blaskovich received 91 votes and there was a scattering of 8 votes.

**FOR SECRETARY OF STATE** – 14,751 total votes were cast: Paul D. Pate received 7,573 votes, Deidre DeJear received 6,796 votes, Jules Ofenbakh received 380 votes and there was a scattering of 2 votes.

**FOR AUDITOR OF STATE** – 14,786 total votes were cast: Mary Mosiman received 6,700 votes, Rob Sand received 7,679 votes, Fred Perryman received 404 votes and there was a scattering of 3 votes.

**FOR TREASURER OF STATE** – 14,739 total votes were cast: Jeremy N. Davis received 6,683 votes, Michael L. Fitzgerald received 7,669 votes, Timothy Hird received 385 votes and there was a scattering of 2 votes.

**FOR SECRETARY OF AGRICULTURE** – 14,726 total votes were cast: Mike Naig received 7,378 votes, Tim Gannon received 6,888 votes, Rick Stewart received 458 votes and there was a scattering of 2 votes.

**FOR ATTORNEY GENERAL** – 12,856 total votes were cast: Tom Miller received 9,669 votes, Marco Battaglia received 3,102 votes and there was a scattering of 85 votes.

**FOR STATE SENATOR-DISTRICT 37** – 893 total votes were cast: Zach Wahls received 604 votes, Carl A. Krambeck received 284 votes and there was a scattering of 5 votes.

FOR SOIL AND WATER CONSERVATION DISTRICT COMMISSIONERS (UNEXPIRED TERM ENDING DECEMBER 31, 2020) – 10,451 total votes were cast; Stacy Hansen received 10,349 votes and there was a scattering of 102 votes. Stacy Hansen was elected.

**FOR PUBLIC MEASURE B (Stockton):** Shall the following public measure be adopted? A local sales and services tax shall be imposed in the City of Stockton at the rate of one percent (1%) to be effective from July 1, 2019, until June 30, 2034. Revenues from the sales and services tax are

to be allocated as follows: 0% for property tax relief. The specific purposes for which the revenues shall otherwise be expended are: Up to 40% for general fund and property tax relief; Up to 40% for Water Infrastructure Improvement; Up to 20% for Park Creation and Maintenance; Or any other lawful purpose as determined by City Council. There were 60 votes cast: 40 votes were cast "YES" in favor of the public measure and 20 votes were cast "NO" against the question. Public Measure B for the City of Stockton was approved.

The meeting was adjourned at 9:24 A.M.
