INTRODUCTION:

The City of Muscatine Public Works Department, in cooperation with the Muscatine Pollinator Project, and The Muscatine Soil and Water Conservation District, submitted a grant application for the Water Quality Initiative Urban Conservation Projects funded by the Iowa Department of Agriculture and Land Stewardship (IDALS). This application is for construction of a bio-retention cell and permeable pavers in the 3rd Street parking lot across from City Hall.

BACKGROUND:

At the end of March 2018 Public Works was notified that the grant application was approved and funding for this project can be awarded. In April 2018 the city entered into a contract with the Iowa Department of Agriculture and Land Stewardship. Due to recent river flooding the project has been delayed. In accordance with IDALS the city has been granted an extension until December 31, 2019. In order for the extension to be approved it must be signed by the Mayor.

RECOMMENDATION/RATIONALE:

Approve and sign Amendment #1 to the grant contract with IDALS. No changes have been made to the contract other than the modified completion date.
