

Muscatine County Board of Supervisors
Monday, August 5, 2019

The Muscatine County Board of Supervisors met in regular session at 9:00 A.M. with Holliday, Sauer, Sorensen and Saucedo present. Mather was absent. Vice-Chairperson Sorensen presiding.

On a motion by Sauer, second by Saucedo, the agenda was approved as presented. Ayes: All.

On a motion by Sauer, second by Holliday, the Chairperson was authorized to execute a Memorandum of Understanding for the FFY 2019 Justice Assistance Grant Direct Award in the amount of \$7,551.60. Ayes: All.

County Engineer Keith White presented a bid for the trade-in of two 2006 Sterling trucks for the purchase of two 2020 Mack Granite 64BR tandem truck cab/chassis units from Twin Bridges Truck City for \$249,000 less a potential trade allowance of \$47,000. White stated he was unable to get bids from H & L Truck Sales, Inc. and GATR Truck Center. On a motion by Saucedo, second by Holliday, the Board approved the purchase of two tandem truck cab/chassis units for use as dump/plow trucks from Twin Bridges Truck City in the amount of \$249,000 less possible trade-in at the discretion of the County Engineer. White updated the Board on secondary road projects.

Conservation Director Curt Weiss updated the Board on the cabin and trailhead projects at Deep Lakes Park and the restrooms and playground project at Discovery Park.

On a motion by Sauer, second by Saucedo, minutes of the July 29, 2019 regular meeting were approved as written. Ayes: All.
