

Muscatine County Board of Supervisors
Thursday, January 2, 2020

The Muscatine County Board of Supervisors met in regular session at 8:15 A.M. with Holliday, Sauer, Mather, Sorensen and Saucedo present.

County Auditor Leslie Soule conducted nominations for Chairperson. On a motion by Holliday, second by Saucedo, Jeff Sorensen was elected Chairperson. Ayes: All. Chairperson Sorensen presided over the remainder of the meeting and conducted nominations for Vice-Chairperson. On a motion by Holliday, second by Sauer, Santos Saucedo was elected Vice-Chairperson. Ayes: All.

On a motion by Sauer, second by Mather, the agenda was approved as presented. Ayes: All.

MUSCOM Manager Chris Jasper updated the Board on MUSCOM operations and equipment. Jasper stated the port fee is not based on a radio count so radios can be added at any time for just the expense of purchasing the radios. Jasper confirmed that the Medical Examiner's office was not part of the original plan, but it has one radio that was intended for the City of Nichols. Jasper stated Nichols does not believe they need that radio. Jasper stated some volunteer fire departments never received all of the radios originally allotted to them. Jasper has been working on a physical inventory of all the radios and bringing back the extras to be reassigned to the department that should have originally received them. Jasper stated he has accounted for all but one of the original radios. Jasper stated the hospital has received a grant for five new radios so he will be getting five of those radios back. In response to a question from Sauer, Jasper stated there are currently no extra radios other than the 25 at MUSCOM that are used in an emergency. Sauer stated 25 seems like a substantial number as backup. In response to a question from Saucedo, Jasper stated the radios purchased in 2015 would be the same as current models.

**RESOLUTION #01-02-20-05
CONSTRUCTION EVALUATION RESOLUTION**

WHEREAS, Iowa Code section 459.304(3) (2003), sets out the procedure if a Board of Supervisors wishes to adopt a “construction evaluation resolution” relating to the construction of a confinement feeding operation structure; and

WHEREAS, only counties that have adopted a construction evaluation resolution can submit to the Department of Natural Resources (DNR) an adopted recommendation to approve or disapprove a construction permit application regarding a proposed confinement feeding operation structure; and

WHEREAS, only counties that have adopted a construction evaluation resolution and submitted an adopted recommendation may contest the DNR’s decision regarding a specific application; and

WHEREAS, by adopting a construction evaluation resolution, the Board of Supervisors agrees to evaluate every construction permit application for a proposed confinement feeding operation structure received by the Board of Supervisors between February 1, 2020 and January 31, 2021 and submit an adopted recommendation regarding that application to the DNR; and

WHEREAS, the Board of Supervisors must conduct an evaluation of every construction permit application using the master matrix created in Iowa Code section 459.305, but the Board’s recommendation to the DNR may be based on the final score on the master matrix or may be based on reasons other than the final score on the master matrix.

NOW, THEREFORE, BE IT RESOLVED BY THE MUSCATINE COUNTY BOARD OF SUPERVISORS to hereby adopt this construction evaluation resolution pursuant to Iowa Code section 459.304(3).
