- A. Vacation of a Portion of Alley Right of Way

This public hearing concerns the vacation of a portion of Alley Right of Way located in Block 29 of the Original town: The City of Muscatine is currently reconstructing the 2nd Street and Mulberry Avenue intersection into a roundabout. As part of this project additional right of way had to be acquired from a number of adjoining property owners, including from HNI Corporation and Dekock Anita LLC. As part of the agreements for the City to acquire the right of way needed for the roundabout project, the City agreed to vacate and convey to HNI Corporation and Dekock Anita LLC, the portions of the alley right of way that no longer serve a current or future public use.

E. Resolution Resetting the Public Hearing on Amendment #1 to the City's FY 2019/2020 Budget

The City Council completed the budget review process for the fiscal year 2020/2021 budget in February. As part of that review, revised estimate revenue and expenditure amounts for the current year (2019/2020) were also reviewed by City Council. Each year, these revised estimate amounts become Amendment #1 to the current year budget.

The public hearing on the budget amendment was originally scheduled for March 19. However, due to the COVID-19 event, this meeting was changed to an electronic call-in meeting. There were several issues with the call-in format at that meeting and the Council chose to schedule another hearing on the budget amendment.

F. Resolution Resetting a Public Hearing on the City Budget for FY 2020/2021

The City Council completed the budget review process for the fiscal year 2020/2021 budget in February. Beginning with the fiscal year 2020/2021 budget two public hearings are now required in order for City Council to adopt the annual budget for the upcoming year.

The first public hearing was held on March 5th at which the City Council approved a resolution setting the maximum tax levy for 2020/2021 for certain levies.

After that action on March 5, the City Council set a public hearing (Hearing #2) on the adoption of the budget and the certification of taxes for the 2020/2021

budget. The public hearing on the budget was originally scheduled for March 19. However, due to the COVID-19 event, this meeting was changed to an electronic call-in meeting. There were several issues with the call-in format at that meeting and the Council chose to schedule another hearing on the budget adoption.
