The Muscatine County Board of Supervisors met in regular session at 9:00 A.M. with Holliday, Sauer, Sorenson, Mather and Saucedo present. Chairperson Sorenson presiding.

On a motion by Saucedo, second by Holliday, the agenda was approved as presented. Ayes: All.

On a motion by Sauer, second by Saucedo, the Board approved Ordinance #11-30-20-01 Regulating the Operation of All-Terrain Vehicles and Off-Road Utility Vehicles in Muscatine County, Iowa on the third and final reading. Roll call vote: Ayes: All. Sorenson reminded the public the ordinance does not go into effect until after publication in one of the official newspapers, which should take about a week. Saucedo recommended the public review the ordinance and be aware of all regulations and restrictions.

On a motion by Sauer, second by Mather, the Board approved the following utility permit: Eastern Iowa Light & Power – set a pole and run power to 1985 215<sup>th</sup> Street. Ayes: All.
