Request Public Hearing for 2020/2021 Hot Mix Asphalt Overlay Project

EXECUTIVE SUMMARY

The City of Muscatine Public Works Department has compiled a list of streets to be overlaid with hot mix asphalt during Fiscal Year 2020/2021. Prior to approving the plans and specifications and soliciting bids, a public hearing is required.

STAFF RECOMMENDATION

Staff recommends Council set a Public Hearing for the 2020/2021 Hot Mix Asphalt Overlay Project. The requested date for this Public Hearing is January 21, 2021 at 7:00 pm in Council Chambers.

BACKGROUND/DISCUSSION

The City of Muscatine Roadway Maintenance Division has compiled a list of streets that qualify for Hot Mix Asphalt overlay based on a matrix previously developed. The project specifications will be made available at the public hearing. This project was delayed due to uncertainty of road use tax revenue due to the Covid 19 pandemic. The streets included in this project are:

- Fair Acres Drive: Bidwell Road to Crestline Drive
- Washington Street: Cypress Street to Walters Street
- Busch Street: Hershey Avenue to Mill Street
- Houser Street: Cedar Street to Karen Drive
- Houser Street: Karen Drive to Mulberry Avenue
- Indiana Street: Schley Avenue to Benham Avenue
- Benham Avenue: Indiana Street to Wisconsin Street
- James Place: Parkington Drive to Dead End
- Dewey Avenue: Indiana Street to Oregon Street
