Resolution Awarding the Contract for the 2020/2021 Hot Mix Asphalt Overlay Project to Manatt's for the amount of \$528,450.00.

EXECUTIVE SUMMARY

The City of Muscatine Public Works Department has compiled a list of streets to be overlaid with hot mix asphalt during Fiscal Year 2020/2021. Bids were received on February 23, 2021 at 10:00 am and have been tabulated (bid tab attached). Manatt's was the apparent low responsive, responsible bidder with a bid of \$528,450.00.

STAFF RECOMMENDATION

Staff recommends Council approve a resolution to award the contract to Manatt's in the amount of \$528,450.00.

BACKGROUND/DISCUSSION

The City of Muscatine Roadway Maintenance Division has compiled a list of streets that qualify for Hot Mix Asphalt overlay based on a matrix previously developed. The bids were received on February 23, 2021 at 10:00 am and have been tabulated. This project was delayed due to uncertainty of road use tax revenue due to the Covid 19 pandemic. The streets included in this project are:

- Fair Acres Drive: Bidwell Road to Crestline Drive
- Washington Street: Cypress Street to Walters Street
- Busch Street: Hershey Avenue to Mill Street
- Houser Street: Cedar Street to Karen Drive
- Houser Street: Karen Drive to Mulberry Avenue
- Indiana Street: Schley Avenue to Benham Avenue
- Benham Avenue: Indiana Street to Wisconsin Street
- James Place: Parkington Drive to Dead End
- Dewey Avenue: Indiana Street to Oregon Street

CITY FINANCIAL IMPACT

The funds for this project come from the Roadway Maintenance Budget. This project was anticipated to cost approximately \$451,000.
