BACKGROUND/DISCUSSION

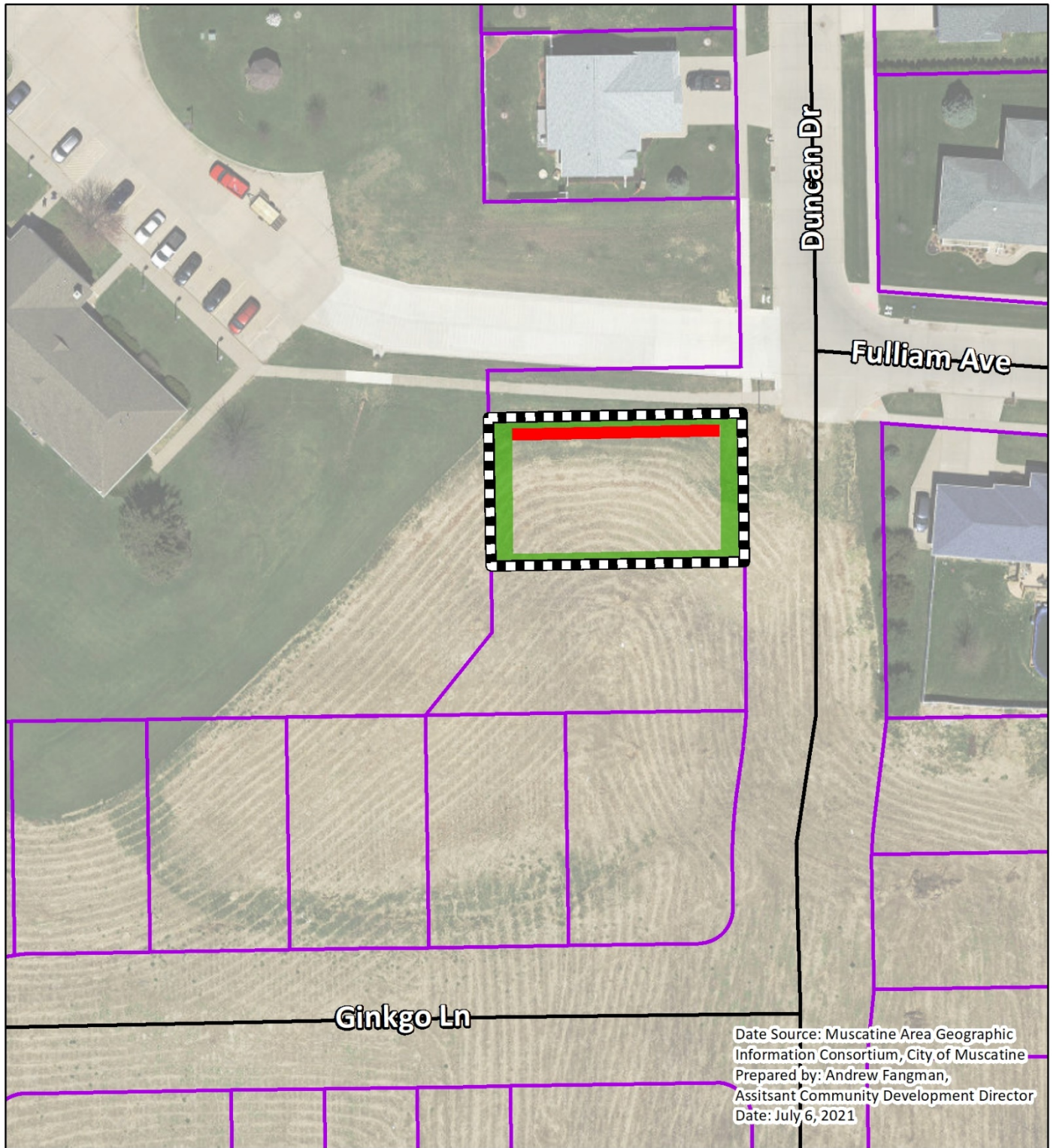

Subject Parcel (Lot 1, Arbor Commons Subdivision)



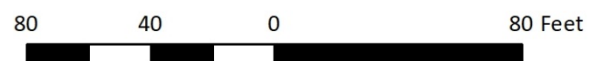
Utility Easement Proposed for Vacation
