EXECUTIVE SUMMARY

The City of Muscatine Public Works Department has compiled a list of streets and alleys to be overlaid with hot mix asphalt during Fiscal Year 2021/2022. Prior to approving the plans and specifications and soliciting bids, a public hearing is required. The requested date for this Public Hearing is August 19, 2021 at 7:00 pm in Council Chambers.

STAFF RECOMMENDATION

Staff recommends Council set a Public Hearing for the 2021/2022 Hot Mix Asphalt Overlay Project. The requested date for this Public Hearing is August 19, 2021 at 7:00 pm in Council Chambers.

BACKGROUND/DISCUSSION

The City of Muscatine Roadway Maintenance Division has compiled a list of streets that qualify for Hot Mix Asphalt overlay based on a matrix previously developed. The project specifications will be made available at the public hearing. The streets included in this project are:

- Fair Acres Drive: Bidwell Road to Crestline Drive
- Robin Road: Bidwell Road to Sunrise Circle
- Bartlett Street: Mulberry Avenue to Cedar Street
- Fletcher Avenue: Hershey Avenue to Fletcher Avenue
- Railroad Avenue: Sampson Street to Schley Avenue
- Wallace Street: LB Trailer Court to Indiana Street
- 5th Street: Mullberry Avenue to Cypress Street

The alleys included in this project are:

- Lincoln Boulevard & Grand Avenue: Clay Street to Jackson Street
- Lake Park Boulevard & McArthur Street: 2nd Avenue to Lake Park Boulevard
- Taylor Street & Clinton Street: New Hampshire Street to Hershey Avenue

- #2 Alley: Linn Street to Pine Street
- Mary Place & Orchard Avenue: Orchard Avenue to dead end
- #10 Alley: Spring Street to Poplar Street

CITY FINANCIAL IMPACT

The funds for this project come from the Roadway Maintenance Budget. This project is an indefinite quantity, indefinite delivery project and is anticipated to cost approximately \$500,000.
