BACKGROUND:

The Municipal Golf Course is due to have the fairway irrigation system replaced as the old system is well past its useful life and is beginning to fail. The project will basically replace the old single row hydraulically controlled system with a modern double row electrically controlled system. The new system will provide for more efficient and effective watering of the fairways.

RECOMMENDATION:

During the FY 2012/13 budget discussions, the City Council approved the Golf Course Fairway Irrigation Project. At this time, it is staff's recommendation to proceed with the plan to replace the fairway irrigation system as requested.
