Re: Resolution Approving and Accepting the O&M Manual for Mad Creek Levee

INTRODUCTION: In September of 2008, the City of Muscatine entered into a Project Cooperation Agreement (PCA) with the Army Corps of Engineers (USACE) to construct a levee improvement project for the Mad Creek Levee.

BACKGROUND: This nearly \$9,000,000 project includes flood protection enhancements from Geneva Creek to the confluence of Mad Creek at the Mississippi River. This low-lying area is subject to flash flooding and consists of a mixture of Industrial, commercial and residential uses, as well as a designated historic downtown district. Major components of the Mad Creek Project included raising existing levees and 1,700 feet of existing floodwalls by approximately 2 feet, construction of 230 feet of new floodwall, construction of a new bulkhead closure gate to replace an aging panel closure structure at Mississippi Drive, replacing an aging floodgate panel structure at Second Street with a rolling closure structure, and the construction of a new flood closure gate south of Washington Street on the rail spur serving Heinz, USA. With the recent completion of the Project, the City has been requested to accept and approve the Operation and Maintenance (O&M) Manual for the Project.

RECOMMENDATION/RATIONALE: City staff is in receipt of this 688-page document and is recommending that the City Council formally accept and approve the O&M Manual as prepared and submitted for the Project. Please place the attached resolution on the agenda for City Council consideration during their May 16, 2013 Meeting
