INTRODUCTION:

Please accept this memo and the attached Resolution Accepting Completed Work performed for the Golf Course Irrigation Project.

BACKGROUND:

The City Council at the October 4, 2012 regular Council meeting awarded a contract in the amount of \$321,200.00 to Midwest Irrigation, L.L.C. of East Dubuque, Illinois to replace and upgrade the original fairway irrigation system at the Muscatine Municipal Golf Course. Contract modifications resulted in a deduction of (\$12,815.00) resulting in a final contract price of \$308,385.00.

RECOMMENDATION:

As the General Contractor, Midwest Irrigation, L.L.C. has satisfied the requirements of the contract, it is staff's recommendation to approve the proposed resolution accepting completed work performed for the Golf Course Irrigation Project and authorizing an immediate payment in the amount of \$65,892.50 to the contractor. Additionally, as required by Iowa Code the retainage of 5% of the original contract price of \$16,060.00 will be held for an additional 30 days.

RESOLUTION ACCEPTING COMPLETED WORK PERFORMED FOR THE GOLF COURSE IRRIGATION PROJECT AND AUTHORIZING FINAL PAYMENT

WHEREAS, the City of Muscatine approved the Plans, Specifications and Form of Contract for the Golf Course Irrigation Project; and

WHEREAS, the City of Muscatine entered into a contract for said project with Midwest Irrigation, L.L.C. of East Dubuque, IL for \$321,200.00; and

WHEREAS, contract modifications resulted in a net deduction of \$12,815.00 and a final contract price of \$308,385.00; and

WHEREAS, all work under this contract has been completed by the contractor, and approved and accepted by the Project Architect and appears to meet the requirements of the Plans and Specifications heretofore adopted by this Council, as evidenced by the Project Architect; and

WHEREAS, the amount of \$226,432.50 has been previously paid to Midwest Irrigation L.L.C. and a balance of \$81,952.50 including the retainage remains due and payable;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MUSCATINE, IOWA, that the City of Muscatine hereby accepts the Golf Course Irrigation Project and authorizes the immediate payment of \$65,892.50 to Midwest Irrigation L.L.C. and authorizes an additional payment of \$16,060.00, which represents the required retainage to be paid, thirty (30) days from the date of the adoption of this Resolution pursuant to Iowa Code Chapter 573.
