## INTRODUCTION:

The City of Muscatine is preparing to reconstruct Colorado Street from Park Ave. to University Drive in 2014.

## BACKGROUND:

In 1933 Colorado Street was the North boundary of the City of Muscatine. In the '60's the Colorado Street/Park Ave. intersection was realigned with Clay Street. As a result of increased growth in the NE portion of the Muscatine community it was determined that Colorado Street needed significant improvements. The City hired the engineering firm, Shoemaker-Haaland, to design the reconstruction. Federal financial aid (\$1.2 million) was obtained and property acquisitions and easements secured to allow the project to move forward. Bid letting is scheduled for September 17, 2013.

## RECOMMENDATION/RATIONALE:

The reconstruction of Colorado includes a new turn lane from Park Ave. onto Colorado, a stop island at University Drive, 3 lane urban section road design, new box culvert, storm & sanitary sewer, water main replacement, private utility relocations and new sidewalks. The design incorporates the "Complete Streets" concept which allows for multimodal transportation. The estimated cost is \$2.95 million.

It is recommended a Public Hearing be set for the August 15, 2013 City Council Meeting.
