BEGINNING AT THE NORTHEAST CORNER OF LOT 4 IN BLOCK 2 OF BURNSIDE'S 2<sup>ND</sup> ADDITION; THENCE SOUTH 48°46'39" WEST 44.00 FEET; THENCE NORTH 41°05'16" WEST 20.00 FEET; THENCE NORTH 48°46'39" EAST 44.00 FEET; THENCE SOUTH 41°05'16" EAST 20.00 FEET TO THE POINT OF BEGINNING; CONTAINING 880 SQUARE FEET.

Exempt from transfer tax per Iowa Code Section 428A.2 (6).

The City covenants with the grantees, its successors and assigns, to warrant and defend the real property against the lawful claims of all persons claiming by, through, or under the City.
