INTRODUCTION:

The City of Muscatine opened bids on Tuesday, August 6, 2013 for the 2013 Asphalt Overlay Project.

BACKGROUND:

The City allocated \$250,000 for asphalt overlay work on Island Road, Island Court, McIntire Road, #2 alley between Cherry & Ash Streets, parking area at Weed Park and participation with the Iowa Department of Transportation for Washington Street from Park Ave. to the corporate limits.

RECOMMENDATION/RATIONALE:

Three bids were received (see attached). The low bid for Island Road, Island Court, McIntire Road, #2 alley between Cherry and Ash Streets and the parking area at Weed Park is \$192,204.00 submitted by Brandt Construction. The city's allocated cost for Washington Street is \$48,000. The total 2013 Asphalt Overlay Project is \$10,000 under budget.

Staff recommends awarding the contract to Brandt Construction Co. of Milan, Illinois.
