INTRODUCTION:

The Iowa Department of Transportation opened bids for the Colorado Street Reconstruction Project on September 17, 2013.

BACKGROUND:

The City of Muscatine has been planning the reconstruction of Colorado Street for the past several years. The plan for Colorado is to make it a “Complete Street” roadway accommodating all forms of traffic – pedestrian, public transit, cycling and vehicular. Sidewalks are a major improvement to this reconstruction plan.

RECOMMENDATION/RATIONALE:

Five (5) bids were received with the low bid submitted by Heuer Construction at \$2,849,949.71. The engineer’s estimate was \$2,950,000. Part of the bid includes work on a water main that Muscatine Power and Water is funding. Attached is the letter of recommendation from Shoemaker-Haaland and the bid tab sheet.

Dear Mayor and Council:

On Wednesday, September 17, 2013 five bid proposals were received for the Colorado Street Reconstruction project as shown on the tabulation of bids attached.

Bids ranged from \$2,849,949.71 to \$3,819,778.85. We have reviewed the bids in detail and have found all of them to be mathematically correct. The low Bid falls below our estimate and the City's budget. We recommend that the City Council award the project to the low bidder, Heuer Construction Inc., of Muscatine, Iowa. Heuer Construction is experienced with this type of work and they have successfully completed similar projects in the past.

The engineers construction cost opinion was \$2,950,000.

If the City agrees with our analysis of project costs and feels that they have the appropriate financial resources programmed, then we recommend the construction contract be awarded for the total bid in the amount of \$2,849,949.71.

We appreciate the opportunity to be of service to the City of Muscatine.
