INTRODUCTION:

The City of Muscatine has privatized the snow removal operations in the Central Business District during the winter season.

BACKGROUND:

Because of the City's Snow Removal Policy and the demands on available Public Works manpower and equipment the City of Muscatine has contracted snow removal in the Central Business District. In order to minimize this cost the Public Works Roadway Maintenance Supervisor has limited the area the contractor is required to clean downtown. Nevertheless, when this service is needed it can get expensive.

RECOMMENDATION/RATIONALE:

Bids were taken on October 11, 2013 for Snow Removal/Hauling in the Central Business District. Two bids were received with Bayfield Snow Removal providing the lowest bid. We have worked with Bayfield the past couple of years with good success. Public Works staff recommends awarding the agreement to Bayfield Snow Removal for the 2013/2014 winter season.
