**Re:** Vacation Request – A Portion of Elm Street and Alley ROW in Block 42

**INTRODUCTION:** A request has been submitted on behalf three separate property owners interested in the vacation and purchase of unused city right-of-way located in Block 42 of Original Town. The first request involves a portion of the platted but unimproved portion of Elm Street located adjacent to Block 42 of Original Town. The second request is associated with the three property owners that abut the platted but unimproved alley right-of-way in Block 42 of Original Town.

**BACKGROUND:** Staff has been working with Mr. Ron Stych on behalf of David Bauerbach, owner of the property at 966 & 968 Elm Street to vacate a portion of the unimproved right-of-way on Elm Street to allow sufficient area for the construction of a new home. Mr. Bauerbach is also interested in acquiring the unimproved alley right-of-way located immediately adjacent to his lot. During a preliminary review of the request, staff suggested that a joint petition be filed involving the remaining property owners that abut the unimproved alley right-of-way in an effort to dispose of this entire unused city property. As a result, the other two adjacent property owners have joined in a request to vacate and purchase a portion of the alley right-of-way that adjoins their property.

**RECOMMENDATION/RATIONALE:** The Planning Commission conducted an on-site viewing of the property on March 2<sup>nd</sup> and reviewed the request during their regular meeting on March 8<sup>th</sup>. The Commission has unanimously recommended that the City Council take action to approve the vacation and transfer of this real estate since it has no future value to the City and would create a building lot for a new home. Prior to any action on the disposal of city property, a public hearing is required. Therefore, it is recommended that the City Council take action to set the required public hearing for Thursday, April 7, 2011 to consider the vacation, sale & transfer of the real estate as set out in the attachments provided with this memorandum.

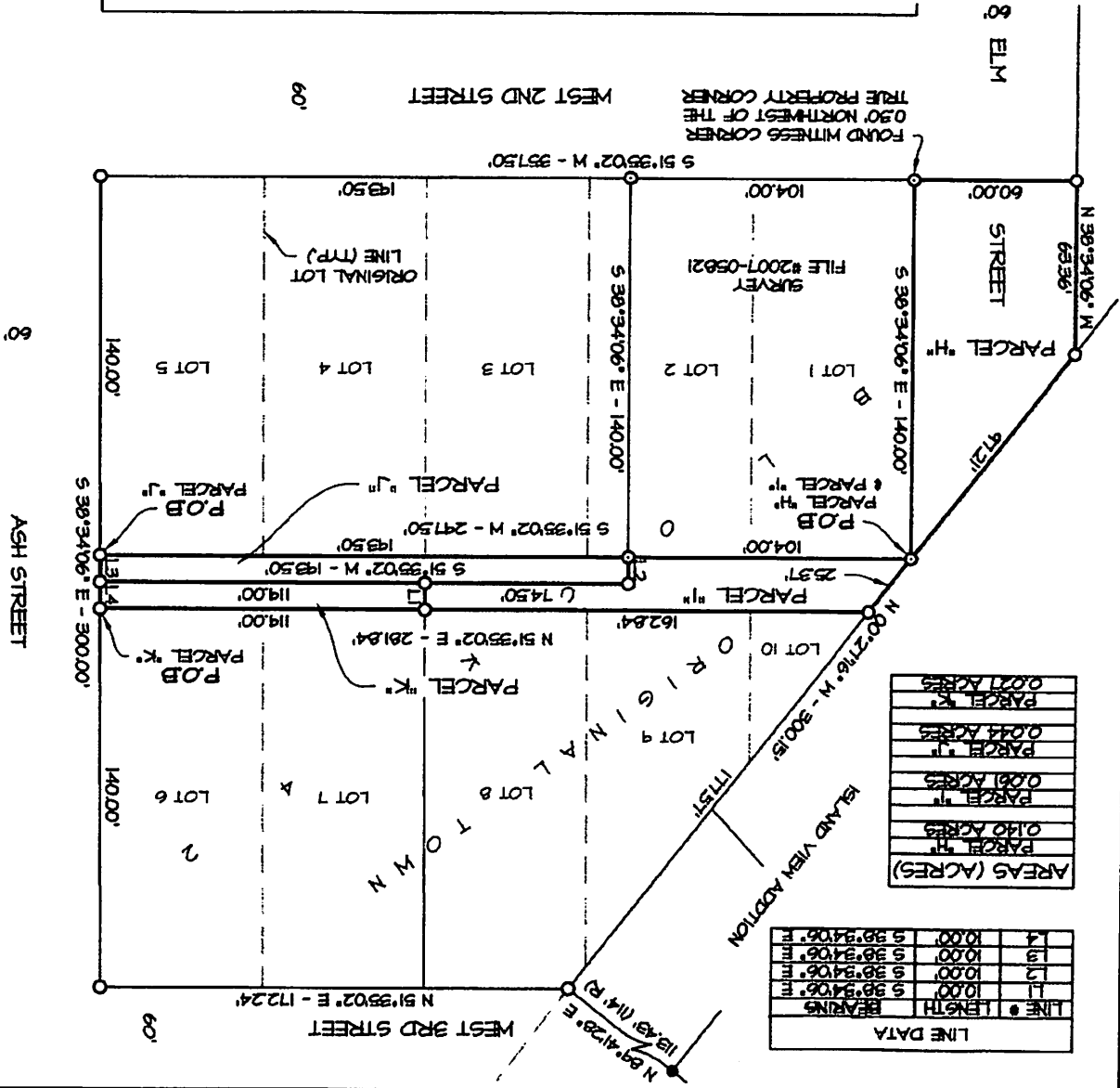
