INTRODUCTION:

Requested for City Council consideration is authorization to purchase a Rubber Tire Loader-Backhoe.

BACKGROUND:

The Public Works Department has \$135,000 budgeted for the replacement of a 1995 Case 590 SL Rubber Tired Loader-Backhoe.

RECOMMENDATION/RATIONALE:

Three bids were received. The low bid was from Titan Machinery in Davenport, Iowa for a Case 590 SN in the amount of \$88,950. Trade In options were considered, but city staff recommends the '95 Case go to the Parks & Recreation Department and offer their 1987 JCB as a Trade In when they receive bids for their track loader. Further, the '95 Case has the "thumb" attachment that is no longer made. This has been an important and useful tool for the type of work we frequently encounter (i.e. brush pickup, cleanup week, concrete removal etc.).

It is our recommendation to purchase the Case 590 SN from Titan Equipment for \$88,950.
