Re: 2nd Street Apartment Parking Lot Improvements – Contract & Bond

INTRODUCTION: The City of Muscatine has entered into a Cooperation Agreement with the United States Army Corps of Engineers (USACE) for the design and construction of improvements to the Mad Creek Levee. Phase II bids have been opened, evaluated and are being prepared for contract.

BACKGROUND: The City is responsible for the acquisition of all temporary and permanent easements necessary for the construction of Phase II. On October 7, 2010, the City Council approved a resolution establishing temporary and permanent easements acquired from the owners of the apartment building located at 903 East 2nd Street. That agreement provides for the city to construct and pay for the parking lot improvements being lost as a part of the Project. Bids for this project were opened on July 25th and the low bid was accepted by the City Council on August 4th. On August 18th, City Council will have the opportunity to approve the contract and bond for the Project.

RECOMMENDATION/RATIONALE: it is recommended that City Council approve the attached resolution approving the contract and bond received from Heuer Construction, Inc., for the project titled "2nd Street Apartments Parking Lot Improvements".

WHEREAS, the City Council for the City of Muscatine, Iowa accepted the low bid from Heuer Construction, Inc. of Muscatine for certain improvements known as the “2nd Street Apartment Parking Lot Improvements” on the 5th of August, 2011, in the amount of \$40,506.20; and

WHEREAS, this Council has authorized and directed the Mayor and City Clerk to enter into a written contract for this project with said contractor, subject to final approval by this Council; and

WHEREAS, the contract and bond has been examined by this Council;
