Re: Water Main Relocation – 2nd St Bridge at Mad Creek

INTRODUCTION: The City and the Corps of Engineers have entered into a Cooperation Agreement for the improvements to the Mad Creek Levee. Phase II of the Project is scheduled to get underway within the next two weeks.

BACKGROUND: The Cooperation Agreement with the USACE requires the city to perform certain tasks related to the Mad Creek Levee Improvement Project, related to lands, easements, relocations, demolition, etc. The most recent activity requires the relocation of the natural gas and water main from their current location near the 2nd Street Bridge crossing Mad Creek. The relocation is necessary to accommodate modifications at the bridge that will be used for a rolling gate closure structure that will protect this area during flooding events.

RECOMMENDATION/RATIONALE: MP&W has assisted the city's engineer for this project and secured three quotations from contractors that have performed similar work for MP&W in the past. The low bid received is from Triple B in the amount of \$35,587.00. It is recommended that the City Council authorize the issuance of a Purchase Order to Triple B in the amount of \$35,587.00 for the water main relocation at the 2nd Street Bridge crossing Mad Creek. This cost will be credited to the City's obligation for the Project.
