PROCLAMATION
MENTAL HEALTH AWARENESS WEEK

WHEREAS, mental illnesses such as major depression, bipolar disorder, schizophrenia, obsessive-compulsive disorder, severe anxiety disorders, borderline personality disorder, and posttraumatic stress disorders can severely disturb a person's ability to think, feel, and relate to other people and the environment; and

WHEREAS, mental illness is more common than cancer, diabetes, heart disease, and arthritis and is the number one reason for hospital admissions nationwide; and

WHEREAS, approximately 7.5 million of the country's youths under the age of 18 have mental, behavioral or developmental disorders with only about 1/5 of that number receiving the necessary mental health treatment; and

WHEREAS, serious mental illness (SMI) afflicts 6% of American adults costing the nation an estimated \$193.2 billion in lost earnings, according to findings published recently in the *American Journal of Psychiatry*; and

WHEREAS, SMIs have been scientifically proven to be highly treatable illnesses of the brain; and

WHEREAS, scientific research is producing tremendous breakthroughs in the understanding of mental illnesses, resulting in more effective treatments that allow people to reclaim full and productive lives; and

WHEREAS, the National Alliance on Mental Illness (NAMI) is a national, grassroots self-help organization working to educate Americans about symptoms and treatment of disorders; improving treatment and access to appropriate medical therapies; reducing the stigma of mental illness; and increasing scientific research in treatment approaches and neuroscience;

WHEREAS, approximately 1/3 of the estimated 600,000 homeless people in the United States have SMI and many prisoners incarcerated in American prisons and jails suffer from mental illness; and

WHEREAS, misunderstandings exist about many mental illnesses and our social culture often wrongly imposes stigma on them.

NOW, THEREFORE, I, Richard W. O'Brien, Mayor of the City of Muscatine, Iowa, do hereby proclaim the week of October 2-8, 2011 as Mental Health Awareness Week and May 2012 as Mental Health Awareness Month in the City of Muscatine to increase public awareness of mental illness.
