RE: Resolution to Amend the Public Housing 2011 Capital Funding Program

INTRODUCTION: Certain capital modifications and revisions have been proposed to update the Muscatine Municipal Housing Agency's (MMHA) 2011 Capital Improvement Plan.

BACKGROUND: In accordance with the MMHA Substantial Deviation policy, the city council acting as MMHA Board of Commissioners has the authority to amend its annual plan without HUD approval.

RECOMMENDATION / RATIONALE: This request will be revision number one. In this revision we propose to remove the \$72,006 Sunset Park asphalt overlay project included in the 2011 Capital fund program budget and utilize Capital funding funds from funding year 2010 that is currently included in our operating fund balance.

The revised plan for Capital funding 2011 includes additional electrical upgrades at Sunset Park and exterior painting and exterior door replacement at the Clark House totaling \$72,006.

This change keeps the Capital fund program balance for 2011 at its HUD-approved level of \$171,006.

On September 29, 2011 the MMHA Resident Advisory Board reviewed and supported this amended plan.
