SUBJECT: Council Agenda Request – Power Cot Purchase Request

INTRODUCTION:

Requesting to purchase Battery Powered Ambulance Cot for new 5th Ambulance from Stryker EMS Equipment.

BACKGROUND:

Currently we have two (2) regular style cots that require manual lifting that have low rating capacities, one (1) battery powered ambulance cot that was purchased in 2006 and we also have one (1) bariatric cot and winch system that was purchased in FY10/11. We will need to purchase a cot for the new 5th ambulance that is being added to the fleet. In order to enhance the safety of the paramedics loading and unloading patients it is recommended that we purchase another battery powered ambulance cot in order to reduce back injuries to staff. With the increase of obesity in patients, new equipment and technology has expanded to make the job easier and safer for paramedics, which reduces back injuries, work comp cases, and enables ambulance services to transport patients safely. The cost of the Power Pro Ambulance Cot is \$ 12,046.50. We have \$ 12,469.55 remaining from 2008 bond proceeds which funded ambulance refurbishments which can be used for this equipment.

Stryker is a sole source vendor for this battery operated ambulance cot so no other quotes are available.

RECOMMENDATION/RATIONALE:

Request authorization to issue purchase order to Stryker EMS Equipment for a battery operated ambulance cot for \$ 12,046.50 with this purchase funded from the remaining funds from 2008.
